

# **NELGA GOOD PRACTICES:**

Development of a Land Management Strategy **for Botswana** 

The Network of Excellence on Land Governance in Africa (NELGA) is a partnership of leading African universities and research institutions with proven leadership in education, training and research on land governance. Currently NELGA has more than **70 partner institutions** in over 40 countries and is organized in 6 regional and 1 technical nodes supported by a Secretariat.



In 2009 the Government of Botswana moved for a comprehensive land reform to deal with some persisted problems/ challenges experienced overtime in land management. Among these problems and challenges include an inefficient and unfair land administration system as well as a lack of transparency in the system. As a result, the Ministry of Lands and Water Affairs (MLWA) in Botswana have commissioned a study to develop a 25-year Land Management Strategy. The Ministry approached the GIZ-SLGA to provide technical and financial support for the project. GIZ has contracted two consultants to undertake the study. A first draft of the strategy was developed in-house by the staff of MLWA in year 2022. The first draft did not take into consideration all relevant national perspectives and international guidelines and standards. The Ministry therefore found it necessary to develop a comprehensive land management strategy that will guide the implementation of reforms in the land sector and be the North Star towards an efficient, fair and transparent land delivery system.

### 2. Implementation

GIZ engaged two consultants namely a NELGA National Consultant (Team Leader) and a NELGA Regional Consultant (International Expert) to develop the Land Management Strategy. To execute this work effectively, NELGA country consultants and the NELGA Regional consultant worked very closely with the government of Botswana (represented by the Ministry of Lands and Water Affairs), and other partners, bilateral technical and financial partners (both in-country and external as necessary) and key stakeholder groups in the Botswana land sector.

## This work is country-owned and led, and comprised of six (6) stages:

#### i) Project initiation Workshop

This entails engagement with stakeholders to set the foundation of the project, agree on the objectives, methodology, preparation of the detailed project plan and list stakeholders to be engaged. The MLWA and NELGA country and regional consultants undertook a stakeholder initiation workshop on 21 March 2024 as part of the process for developing the Land Management Strategy. Project initiation document was produced in April 2024. The workshop was followed by a countrywide mission in Botswana for stakeholder engagements on 07-30 May 2024.

### ii) Interim report

A mid-project review highlighting progress and any adjustments needed was produced in June 2024. This report also presents a summary of deliberations, findings and tentative recommendations resulting from the engagement mission which was held on 7-30 May 2024.

### iii) Draft Land Management Strategy

Development of the Land Management Strategy, its implementation plan, and Monitoring and Evaluation (M&E) Framework in two stages. The first draft was submitted for review and feedback at a workshop in August 2024. Inputs was used to update the strategy into a second draft LMS.

### iv) Validation Workshop

A validation workshop will be organised for the key stakeholders to review and provide inputs for further refinement for the second draft LMS. The consultant with support from the MLWA will facilitate the validation workshop.

## v) Final Land Management Strategy and final documents

The final validated LMS incorporating feedback from the Ministry of Lands and Water Affairs (MLWA) and other key stakeholders. A simplified version for easy understanding will be prepared based on the final document. The final reports by the consultants will be submitted.

### vi) Implementation and Monitoring of the LMS

The final stage is the implementation and monitoring of the LMS and will be led by the Government of Botswana.

### 3. Results and Lessons Learnt

- Number and composition of stakeholders is sufficient and representative on the findings
- Several workshops/meetings were held including Stakeholder initiation workshop, Validation Workshop etc.
- A number of outputs have been produced including; project initiation document, Interim/progress report, Back to Office Report and draft Land Management Strategy.
- It was quite challenging to adhere to the timelines due to circumstances related to partners and stakeholder which are beyond control, but the ability come up with alternative approaches and flexibility made it possible to achieve objectives.
